 2. The Maximum age limit of the applicant is 55 years.
 3. The application along with all documents claiming achievements and experience must be self-certified.
 4. The applicants must be nominated by two and must be one from eminent pharmacologists who is life members of the IPS.
 5. The applicants served for two consecutive terms as Chief Editor is not eligible to submit the application.
 6. The application of applicant under suspension, involved in any legal cases, involved in any financial fraud will be rejected by Executive committee.
 7. Applicants must submit "No Objection Certificate" from their respective organisation to take this honorary assignment.
 8. The applicant should submit "No Conflict of Interest" declaration along with application.
 9. The applicant should not canvass by any means to get nominated for the post of chief editor.
